I would like Helen & Douglas House to reclaim the tax on my donation(s) and confirm that I have paid at least 25p UK income tax and/or capital gains tax for each £1 donated under gift aid. This means that the charity will receive 25p for every £1 donated under Gift Aid.

By completing this form you are confirming that:

- You wish Helen & Douglas House to claim tax on all donations you make in the future or have made in the past 4 years.
- You are a UK taxpayer and understand that if you pay less Income Tax and/or Capital Gains Tax than the amount of Gift Aid claimed on all your donations in that tax year it is your responsibility to pay any difference.
- You wish Helen & Douglas House to act as your agent in selling the goods you have brought into the shop, at a rate of 1% commission + VAT
- You are not acting as a business in bringing goods in for sale to any shops belonging to Helen & Douglas House.

If you pay income tax at the higher rate, you must include all your Gift Aid donations on your Self Assessment tax return if you want to receive the additional tax relief due to you.

Any goods which cannot be sold will be recycled and cannot be returned to the donor. We reserve the right to terminate this agreement at any time.
